Subject: - Appointment of Non-Teaching Employees on Contract.

The undersigned is directed to convey that the Board of Governors of the Institute in its 9th Meeting held on 2nd May 2012 vide its Agenda Item No. **BOG.9-2** on the recommendation of the Assessment Committee constituted to review the performance of the employees appointed on contract in the initial year of the commencement of the Institute has approved extension of the period of contract and rationalization of emoluments in respect of 27 such employees for one / three years w.e.f. 1-1-2012. Details of such employees indicating their extended period of contract and consolidated monthly salary are given in **Annexure-I**.

- 2. In addition to consolidated salary, these employees would be entitled to leave up to 30 days per annum @ 2.5days per month. Medical facilities as applicable to regular employees of the Institute shall be admissible to these employees for self alone. Rate of annual increase in consolidated salary would be at the rate of 5% of such salary.
- 3. Tenure of appointment on contract may be curtailed or extended subject to satisfactory performance based on annual assessment of the employee concerned and exigencies of work. The period of contract may be terminated by giving one month notice from either side or monetary compensation equivalent to one month's salary in lieu of notice period.
- 4. Such employees would have to sign a contract with the Institute in the prescribed format within a period of one month from the date of issue of this order in this regard.
- 5. Payment of consolidated salary and other facilities for these employees would be retrospectively effective from 1-1-2012.
