ANTI-RAGGING MEASURES

Ragging, in any form, is totally banned in the Institute and its Hostels.

**Anyone indulging in such acts shall be subjected to punishment by the
Concerned authorities and/or a Court of Law**

WHAT IS RAGGING?

“Ragging” means causing, inducing, compelling and/or forcing a Student, whether by way of a practical joke or otherwise, to do any act which detracts from human dignity, or violated his/her person, or to expose him/her to ridicule, or to forebear from doing any lawful act, by intimidating, wrongfully restraining, wrongfully confining, or injuring him/her, or by using criminal force to him/her, or by holding out to him/her any threat of such intimidation, wrongful restraint, wrongful confinement, injury, or the use of criminal force.

SUPREMECOURTVERDICTFORSTRINGENTACTION INCASEOFRAGGING:

Supreme Court of India in its recent direction to the educational institutions pronounced that all educational institutions should obtain an UNDERTAKING from each candidate at the time of admission to the effect that, he/she is aware of the system of punishment in case of ragging to other students. And that, in case he/she is involved in any case of ragging ,he/she is aware of this scale of punishments, including criminal action, cancellation of admission ,expulsion from hostel, withdrawal of scholarship, imposition of fine up to Rs.25,000/-,and/or rigorous imprisonment up to 3(three) years, etc.

All candidates and their parents/guardians, in their own interest, are advised to make themselves acquainted with the relevant rules, regulations, provisions of law, as well as decisions of various Courts of Law, including those of the Apex Court, in relation to anti-ragging measures in India.

 - e) *Withholding results of any test/examination;*
 - f) *Debarring from representing the Institute in any campus interview;*
 - g) *Debarring from representing the Institute from attending/ participating in any national or international meet/tournament/youth festival, etc.;*
 - h) *Suspension/expulsion from the hostel;*
 - i) *Rustication from the Institute for such period as may be decided by concerned authorities;*
 - j) *Expulsion from the Institute and consequent debarring from admission to any other educational institution, for such period as may be decided by concerned authorities;*
 - k) *Imposition of fine up to Rs.25,000/- (Rupees Twenty Five Thousands);*
 - l) *Rigorous imprisonment up to 3(three) years (by a Court of Law), etc.*
2. That, I, hereby, declare that, I am aware of the Supreme Court of India directive, as well as the prevalent laws/rules etc., on anti-ragging, prescribed by Govt. of India, State of Odisha and the Institute authorities.
3. That, I, further declare that, I fully understand the meaning of 'Ragging' and know that ragging in any form is a punishable offence and the same is banned by the Laws of the land.
