Earlier IIT Bhubaneswar was functioning under the aegis of IIT Bhubaneswar society and the BOG was the competent authority for appointment of professor on reemployment basis after superannuation. The institute came under the Institutes of Technology Act 1961 w.e.f. 21.06.2012 in accordance with Rule 15(2) of the Statute, the Board with the approval of the Visitor may appoint a faculty after superannuation for a period upto 3 years in the first instance and upto 2 years thereafter not exceeding the age of 70 years of age.

In view of the above, the Board may formally approve the reemployment of the above faculty for a period of 3 years not exceeding the age of 70 years before the proposal is submitted to MHRD for obtaining the approval of the Visitor. Since the appointment offer was issued before the Institute came under the Act and the above faculty members have joined during the intervening period, the Board may also kindly approve their continuation on provisional basis against the sanctioned vacant posts of the Professor on re-employed basis.

So far, the Institute has been very selective in its recommendations for Honorary Professor, and such nominations have been made only for those professionals who have made most outstanding contribution in their field. Keeping in view of their stature it is now proposed to rechristen the position of Honorary Professor as Honorary Institute Professor. It is perceived that this will further benefit the Institute in fulfilling its desired objective as stated earlier.

The Ministry of HRD, (Deptt. of Higher Education) Govt. of India vide its letter No.8-9/2008-TS.I dated 28th December 2011 has communicated the decision of the Cabinet regarding long term deputation of the employees of the Central Govt./Central Autonomous Bodies to newly set up Central Educational Institutes / Science Institutes including new IITs for a period of 10 years at a stretch in relaxation of provision under the existing recruitments rules and such other rules and order in this regard. The said order also provides for continued deputation of the existing employees already on deputation to new CEIs as on 11-8-2011 for period of 10 years not exceeding their superannuation / absorption.

The Ministry has asked all the Educational Institutes under its administrative control to make necessary enabling provision in their regulation / statutes / MOA of the Institute for implementation of the above decision.
