Rules for Branch Change:

- 1. The applicants have to complete all the credits requirements in the first two semesters of their studies in the first attempt, without having any backlog and must obtained a CGPA of not lower than 8.5, at the end of the second semester.
- 2. The applications received shall be examined after the declaration of result of Second (Spring) End Semester Examination.
- 3. **All changes of branch will be final and binding on the applicants**. No student will be permitted, under any circumstances, to refuse the change of branch offered.
- 4. The list of students who are allowed for change of branch shall be declared before the date of registration of the 3rd Semester (Autumn) 2018-19 and new Roll No. will be assigned to the students.
- 5. Change of branch shall be made strictly on the basis of inter se merit of the applicants. For this purpose the CGPA obtained at the end of the Second (Spring) Semester shall be considered. Ties will be broken by the JEE rank of the applicants.
- 6. No correspondence through e-mail will be accepted on this matter.
- 7. The change of branch, after 1st year of the programme, for the dual degree students is allowed among the dual degree programmes only.
- 8. The last date for submitting the signed hard copy of application to Academic Section is on or before 16th April 2018.
