**2. Through Demand Draft (Only for the Students who have taken Bank Loan) / NEFT (Online Transfer) by concerned Bank**

- (i) Students who have taken Bank Loan may pay their fees through Demand Draft issued by the respective bank along with the letter issued by the Bank authority. Students are required to pay the Institute fee in shape of a DD drawn on any Nationalized Bank in favour of “**Registrar IIT Bhubaneswar**” and the Hostel Mess Advance in favour of “**IIT Bhubaneswar Hostel Account**” payable at Bhubaneswar respectively.”
- (ii) Instead of issue of Demand Draft, **only the loan sanctioning Bank authority (not by the student) can transfer the amount through NEFT (Online Transfer) to State Bank of India A/c No. 30824066553, IFSC Code: SBIN0004414, Fortune Tower Bhubaneswar, Account Holder Name: Registrar IIT Bhubaneswar. The Bank has to mention in the transaction narration: the name of the student, Roll No. and the Semester for which the loan has been sanctioned.** Students have to send the loan sanction letter issued by the bank authority to [office.academic@iitbbs.ac.in](mailto:office.academic@iitbbs.ac.in) at the time of payment of semester fees.

**N.B. Students availing Bank loans may deposit fee by 25.08.2020. They have to inform the Academic Office with loan sanction letter from the concerned bank by 10.08.2020**
